APPROPRIATION ORDINANCE FOR THE VILLAGE OF CERRO GORDO, ILLINOIS FOR THE FISCAL YEAR 1985-1986

BE IT ORDAINED by the President and Board of Trustees of the Village of Cerro Gordo, Piatt County, Illinois, THAT:

SECTION ONE: The sum of \$911,508.00 be and the same is hereby appropriated for the general and corporate purposes and objects of the Village of Cerro Gordo, Illinois, to defray all the necessary expenses and liabilities of the said Village of Cerro Gordo for the current fiscal year.
